The following are probably about 15-25 minutes from Sand Point.

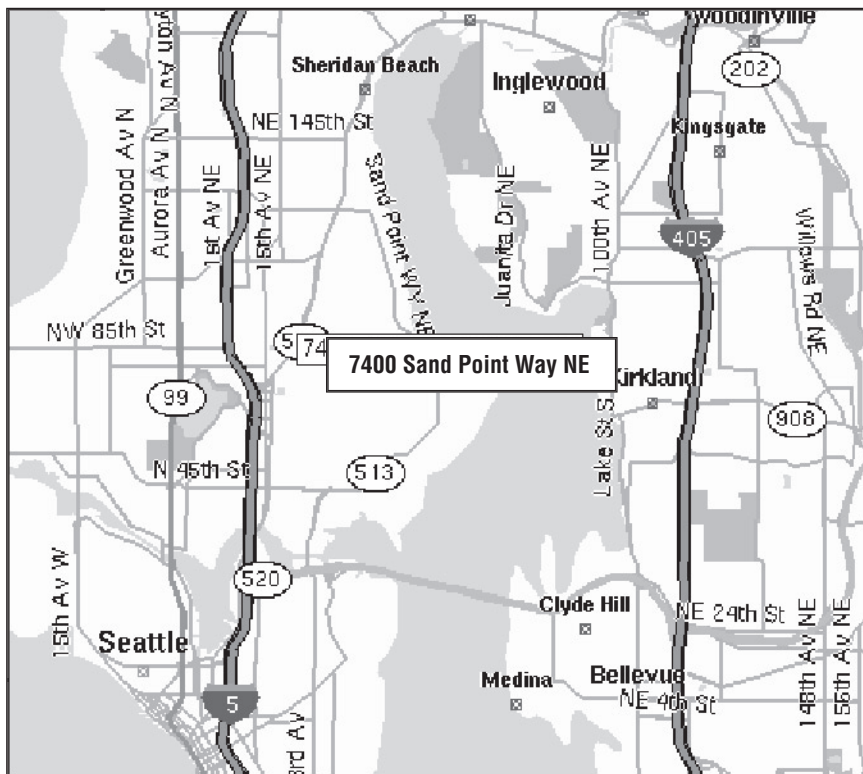
Aurora Ave. is a major arterial; lots of traffic lights, but speed limit is mostly 35-45 mph.

FROM I-5 SOUTHBOUND: Take NE 145th St. Exit. Turn Left onto NE 145th St. Turn Right onto 5th Ave. NE. Turn Left onto NE 130th St. Bear Right onto Roosevelt Way NE. Continue onto NE 125th St. Follow as road goes into Sand Point Way NE. Go approx. 3 miles.

FROM I-5 NORTHBOUND: Bear Right onto Hwy. 520 (East). Bear Right onto E. Lake Washington Blvd. Turn Left onto Montlake Blvd E (Hwy 513). Follow as road goes into Montlake Blvd NE. Follow as road goes into NE 45th St. Continue onto Sand Point Way NE. Go approx. 2 miles.

FROM I-405: Take Hwy. 520 (West) over Evergreen Point Bridge. Take Ramp onto Montlake Blvd E (Hwy. 513). Follow as road goes into Montlake Blvd NE. Bear Right onto Sand Point Way NE. Go approx. 2 miles.

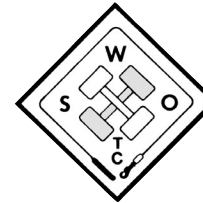

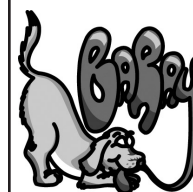

- NOTICE TO EXHIBITORS –
- The AKC will collect a \$1.50 AKC Event Service Fee and a \$.50 AKC Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Chapter 11, Section 2). At every licensed or member club Rally Trial, a Recording Fee of \$3.00 shall be required for the each entry of a dog. (AKC Rally Regulations, Chapter 1, Section 3). A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
 - Dogs need be present only for scheduled judging and will be released if not needed for further judging.
 - Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or agents of Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of dogs in the judging rings.
 - Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made.
 - RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY BASIS.
 - REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
 - Only dogs entered in these trials will be admitted into show area. There is no provision for unentered dogs.
 - LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children on the day of the show.
 - TROPHIES & PRIZES will be awarded in the ring to person exhibiting the dog. No awards will be mailed.
