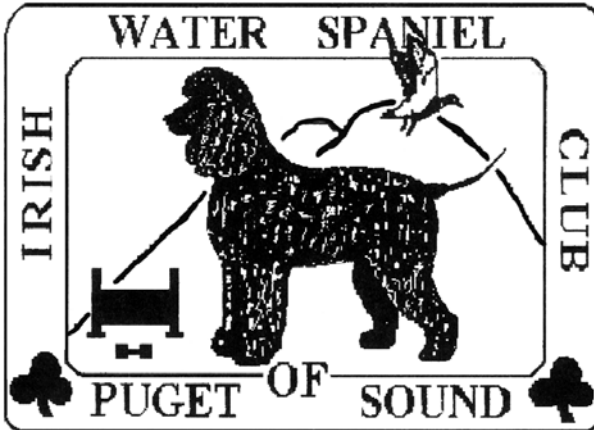

NOTICE TO EXHIBITORS REGARDING CORRECTIONS OR CHANGES TO ENTRIES: Corrections other than the specific changes listed in Ch. 11, Sec. 6 (i.e. sex of a dog, transfers between age specific classes, and "move-up's" to BOB or BOV) are the only changes to the entries superintendents or secretaries are authorized to make after closing of entries. - NOTICE TO EXHIBITORS -

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

- The AKC will collect a \$1.50 AKC Event Service Fee and 50 cent Recording Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees to be collected on the first entry only. (AKC Rule. Ch. 11, Sec. 2). Rally Trial: The AKC will collect a \$3.00 Rally Event Service Fee per entry of dog. (AKC Rally Reg., Ch. 1, Sec. 3). A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
- **CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS**
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are **NOT ACCEPTABLE**. The Club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR THE COMPLETENESS AND CORRECTNESS OF ENTRY RESTS SOLELY WITH THE ENTRANT.**
- Entry fees shall **NOT** be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for **DUPLICATE ENTRIES** or **OVERPAYMENTS**. The Superintendent will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show **NO REFUND** will be made.
- **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.** The Superintendent will add a \$20.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a **CASH ONLY BASIS**.
- **REFUNDS** for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent **AFTER THE SHOW**. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Only dogs eligible for these shows will be admitted into the show area. There is no provision for unentered dogs.
- **ENTRIES WILL BE ACKNOWLEDGED** after entries close with entry acknowledgment and judging program to address on entry. Should Exhibitor **NOT** receive an acknowledgment within a reasonable time, **PLEASE** notify the Superintendent at (360) 683-1507 or email dogshows@barayevents.com.
- **LOSS OR DAMAGE** – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows.
